

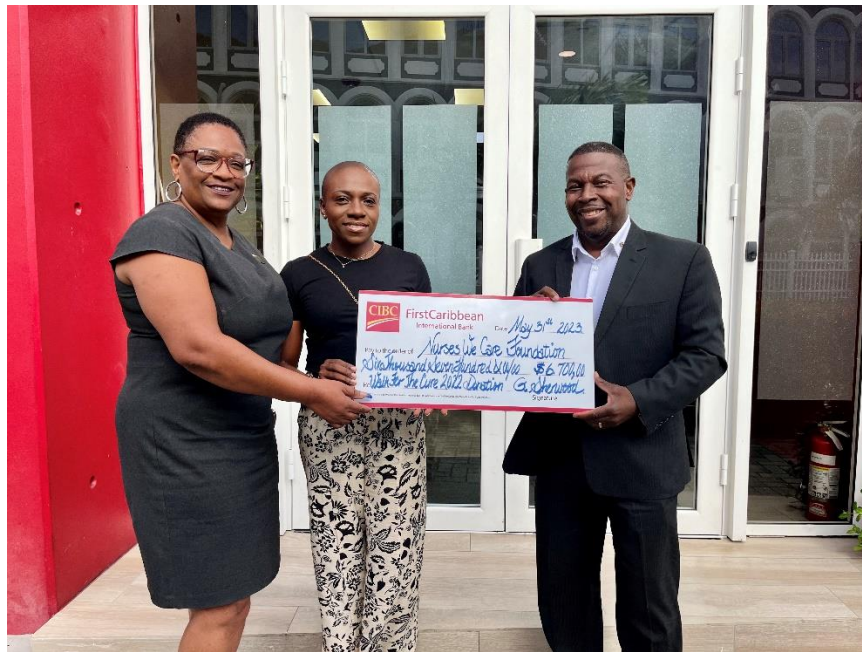
**CIBC FIRSTCARIBBEAN'S MOVE FOR THE CURE
